- a) Termly Fees and all other charges are payable on or before the first day of term by direct debit. A late payment surcharge will be made on overdue accounts in accordance with our Standard Terms and Conditions.
- b) The Standard Terms and Conditions of Sedbergh School, in particular clause 4.6, refer to the exclusion of a pupil at any time where fees are unpaid. Such exclusion may be intimated to apply at either half term or the end of the term in which the fees are unpaid. A pupil will be deemed withdrawn without notice 28 days after exclusion.
- c) Notice must be given *before* the beginning of each term or half term if Music or LAMDA lessons are no longer required. Lessons will be charged until the proper notice has been given whether the pupil attends the lessons or not.
- d) Termly Fees cover board, residence, tuition, laundry charges.
- e) All Termly Fees and other charges are subject to termly reviews in accordance with our Standard Terms and Conditions.
- f) Any remaining Acceptance Deposit will be credited to a pupil's final account on leaving in accordance with the Standard Terms and Conditions.
- g) Fees in lieu of notice are payable at the start of the term to which they relate.
- h) Please refer to clause 3.3 and 3.4 of the School's Terms and Conditions regarding deposits.
- i) We accept Childcare Vouchers in accordance with current legislation.
- j) Parents can opt out of the Old Sedberghian Subscription by contacting the Billing Manager.
- k) Optional fees are payable in arrears on the pupils School account.
